- <u>ARP Funds</u>
  - <u>The second and final deposit received in July. Town Council amended the ARP Budget –</u> <u>August 1, 2022</u>
  - Staff has consolidated all ARP Funds held at Home Trust Bank into one ARP account
  - <u>Staff continues to develop the policies required by the Federal Government in order to</u> <u>comply with regulations to transfer the ARP Funds to the General Funds account.</u>
    - Considered "Revenue Replacement" and is approved by Federal and State Governments.
    - <u>Adoption of the policies is required in order to transfer the funds.</u>

### **Council Discussion**

- MPO Widening of Hickory Tree Road scheduled for 2028
- Widening of Hebron Church Road Old Highway 52 and Gumtree Road in preparation for the Bridge Replacement Project on Gumtree Road
- Artsy Daisy to begin serving shaved ice cream at her location on Gumtree Road. Has obtained all the required permits.
