- □ Town Manager Tammy Michael reported that she had received a request from Oak Grove High School to use the Town Park for cross country track meets that could impact liability insurance for the park.   - Liability issue and impact on cost of liability insurance
  - Not geared for organized sports
  - Grounds not conducive (tree holes)
  - Parking limitations
  - Staffing not available
  - Ongoing construction at the park
  - Bridge construction on Gumtree Road
