

**MINUTES OF MIDWAY TOWN COUNCIL REGULAR MEETING HELD ON JULY 10, 2023,  
AT 7:00 P.M. IN THE COUNCIL CHAMBER AT MIDWAY TOWN HALL, 426 GUMTREE  
ROAD, MIDWAY, NORTH CAROLINA**

**CALL TO ORDER**

Mayor John Byrum called the meeting to order.

Mayor Byrum gave the invocation and led in the Pledge of Allegiance prior to the opening gavel.

**APPROVAL OF MINUTES**

On motion by Councilor Jackie Edwards, seconded by Councilor Robin Moon, Council voted unanimously to approve the minutes of the June 5, 2023, regular meeting as presented.

**CONTRACT – CANNON & COMPANY – ACCOUNTING SERVICES**

Cannon & Company, LLP has submitted its proposed contract for accounting services to the Town of Midway for the period of July 1, 2023 to June 30, 2024. The cost of these services will remain the same at \$1,000.00 per month and there are no changes to the scope of services that Cannon & Company will provide to the Town. Town Attorney Jim Lanik has reviewed and approved the contract presented to Council.

On motion by Councilor Keith Leonard, seconded by Mayor Pro Tem Mike McAlpine, Council voted unanimously to approve the contract with Cannon & Company, LLP for the period of July 1, 2023 to June 30, 2024 for providing accounting services to the Town of Midway in the amount of \$1,000.00 per month.
